



FORM AND PRESENTATION OF MANUSCRIPTS

The objective of this journal is to publish research oriented to the approach and possible resolution of regional problems. Original and unpublished manuscripts will be received. The manuscript must be part of the thematic areas of the journal. The form of publication is continuous and open access (free for both authors and readers).

Thematic areas:

- Environment, Agroindustry and Earth Sciences
- Human Health Sciences
- Social and Human Sciences
- Veterinary Sciences

The manuscript should be submitted through the OJS electronic publishing system (http://revistas.umaza.edu.ar/index.php/icu).

Registration in the system: One of the authors of the manuscript must enter the system, acquire a username and password (corresponding author), and upload the manuscript following the indications provided by the OJS system.

Support: the document shall be written in Microsoft Word, A4 size, Times New Roman 12 font, 1.5 mm spacing, 2.5 cm top and bottom margins, and 3 cm left and right margins.

Attach Files

Upload the following files:

- 1. **Cover letter:** Statement of personal data, authorship, affiliations, ethics, originality, and authorization of the author(s) for the publication of the manuscript.
- 2. Initial page: contains the personal data and affiliation of the author(s).
- 3. **Manuscript:** remember that this file should not contain the names and surnames of the authors.
- 4. **Tables:** In addition to being included in the body of the manuscript, each table should be attached in a separate Word file, which should be named by table number. Correlative numbers should be used, as they appear in the manuscript (e.g. Table 1, Table 2, etc.).
- 5. **Figures:** should be included in the body of the manuscript and attached separately, in a JPG or TIFF file, numbered consecutively (e.g. Figure 1, Figure 2, etc.), and with a minimum resolution of 300 DPI.

Description of the attached documents

- **1. Cover letter:** Declaration of personal data, authorship, affiliations, ethics, originality and authorship.
 - a) Acknowledgment of authorship and authorization for publication and dissemination. Signed by all authors (may contain digital signatures).
 - b) Declaration of originality and non-plagiarism.
 - c) Declaration that the work has not been previously published or submitted simultaneously to another journal.
 - d) Conflict of Interest Statement. A conflict of interest is considered to exist when a participant in the writing, review, and/or publication process has ties to activities or persons that may influence his or her judgment. A conflict of interest may consist, for example, of an author having an employment/financial/personal relationship with a pharmaceutical company, related in some way to the research. Other conflicts of interest



may be determined by personal relationships and academic rivalries, among others. If you do not have any conflict of interest, you must expressly declare it.

- e) Proposal of three potential reviewers, with affiliation and e-mail contact.
- **2. Initial page:** This document will indicate.
 - a) The title of the article in English and Spanish must be informative and concise (maximum 20 words).
 - b) Full names of the authors and the institution of affiliation: The surname(s) should be indicated first, followed by a comma, and the first name(s), without abbreviations. Each author should be separated from the next by a semicolon. Each author should be followed by a number in the superscript to indicate affiliation.
 - c) Affiliation should be separated by periods without abbreviations, acronyms, or initials. List the highest ranking institution first, with its affiliations next, separated by a period followed by a space. At the end of the list of affiliations place a semicolon, a space followed by the country.

 - 2. Juan Agustin Maza University. Regional Parasitology Research Center; Argentina.
- **3. Manuscript.** The following types of manuscripts fall under this section: full articles, short communications, reviews, methods or protocols, and case studies. Essays and editor letters are excluded.

Manuscripts will be evaluated by peers who will not know the authors' data. For this reason, the names of the authors are not included in this file to maintain anonymity.

This document must include:

- ✓ **Title** of the manuscript written in Spanish and English. With a maximum length of 20 words.
- ✓ **Summary and abstract:** It will include an introduction (background or art history, including well-defined objectives), materials and methods, results, discussion, and conclusions, between 150-250 words, without placing the corresponding subtitles. It should not include abbreviations or bibliography. Written in Spanish and English.
- ✓ **Five keywords** in Spanish and English. They must be in uppercase, followed by lowercase, separated by semicolons. They should not be present in the title of the manuscript.
- ✓ **Introduction:** It must contain the background, theoretical and objective framework, and/or hypothesis of the work; not include results or conclusions thereof.



- ✓ Materials and methods: This section describes the methods, techniques, type of study, population and sample, and procedures by which data have been collected and analyzed. When appropriate, it must include the statistical analyses used.
- ✓ **Results:** Must be described clearly, mentioning the table or figure with the corresponding number (figures or tables must be mentioned with a capital letter followed by a lowercase letter without abbreviation, for example: Figure 1, correlatively as they appear in the text), they should not include speculation or personal appreciation. This section does not include the interpretation of the observations made.
- ✓ **Discussion:** In this section, you must state how the results are interpreted, according to your own opinions and the relationship with other (citable) publications, including the sources of bias or limitations and the implications. When appropriate, the acceptance or rejection of the proposed hypothesis is analyzed. A combined Results and Discussion section is often appropriate. Avoid extensive citations and discussion of published literature.
- ✓ **Conclusions:** In this section, the authors should very briefly, (approximately 100 words), synthesize the contribution to the most relevant knowledge of the work presented.
- ✓ **Acknowledgments:** detail in this section, where appropriate: recognition of individuals or institutions (technical support, contributions, and/or financial contributions).
- ✓ Bibliography: Only A.P.A. standards, the latest version, are accepted. Do the same according to: https://normas-apa.org. Also, whenever possible you should provide DOI or URL extensions.

3.1. Manuscript body for essays

- ✓ **Title** of the manuscript written in Spanish and English, with a maximum length of 20 words. Remember not to include names and affiliations in this document.
- ✓ **Summary and abstract:** It will include an introduction (background or art history, including well-defined objectives), development, and conclusions, between 150-250 words, without placing the corresponding subtitles. It should not include abbreviations or bibliography. Written in Spanish and English.
- ✓ **Five keywords** in Spanish and English. They must be in uppercase, followed by lowercase, separated by semicolons. They should not be present in the title of the manuscript.
- ✓ Introduction: It must contain the background, theoretical and objective framework, and/or hypothesis of the work.
- ✓ **Development:** Here the author should present his arguments and main ideas, in an organized manner, and whenever possible, citable evidence should be presented.
- ✓ **Conclusions:** In this section, the authors should very briefly, (approximately 100 words), synthesize the contribution to the most relevant knowledge of the work presented.
- ✓ **Acknowledgments:** Recognition of individuals or institutions (technical support, contributions, and/or financial contributions).



✓ Bibliography: Only A.P.A. standards, the latest version, are accepted. Do the same according to: https://normas-apa.org. Also, whenever possible you should provide DOI or URL extensions.

4. Tables (if applicable)

The table number (e.g., Table 1) followed by an informative title should be indicated at the top of the table. Abbreviations and statistics used, if any, should be indicated at the bottom. They should be included in the body of the paper and attached in a separate file in Word format.

5. Figures (if applicable)

They include photographs, images, or graphs. They should have a heading indicating the figure number (example: Figure 1), an informative title, a description of the method used in the corresponding cases, abbreviations, and statistics used.

Footnotes to tables or figures should contain the information necessary to interpret them without having to refer to the text of the manuscript.

JPG or TIFF images in real size at 300 DPI are allowed. They should be included in the second document, in the body of the manuscript, where the author considers pertinent, and should also be attached in black and white or color (additional charge) in a separate file.
